




# Executive Summary: A Clash of Economies

## Majority-Coded Context



Neurotypical brains process the world like a prism, intuitively scattering a single input into a spectrum of relative meanings based on the unspoken social environment.

## Autistic Context



Autistic brains process the world like a laser, utilizing absolute thinking to zero in on the precise, intrinsic, and invariant properties of a stimulus itself.

Understanding this neuro-cognitive divergence shifts our focus from fixing a blindness to bridging a clash of communicative economies, fostering genuine neuro-harmony.

# The Science: Predictive Coding & HIPPEA

## The Text Synthesis

Structural Label

### 1. The Predictive Engine

The brain constantly balances sensory input against prior models. In autism, this balance functions differently at a sub-second neurological level.

### 2. HIPPEA


High, Inflexible Precision of Prediction Errors in Autism. Autistic brains assign high weight to sensory input rather than overriding it with assumed contextual models (Lawson, Mathys & Rees, 2017).

### 3. The Result

The brain treats every situation as structurally novel, forcing a reliance on the absolute properties of a stimulus rather than its relative, context-dependent meaning.


## The Visual Scale

What clinical literature labels blindness is experienced internally as a commitment to structural clarity over ambiguous social conventions.

## Context Sovereignty

Autistic directness isn't an absence of context; it is a prioritization of a different layer of context: regularity, anomaly detection, and absolute rule-consistency.



# Common Misconceptions: The Clash of Economies

## The Neurotypical Economy

### Myth: Poor Perspective-Taking

Privileges reading between the lines; expects face-saving and subtle flattery.

Re-evaluated as

## The Autistic Economy

### Reality: Refusal of Flattery

Autistic honesty underperforms on tests that penalize saying exactly what is meant (Ishikawa et al., 2017).

### Myth: Literalism is a Deficit

Relying heavily on unspoken hierarchy, euphemism, and double-speak.

Re-evaluated as

### Reality: Clarity as Respect

Demanding clarity is an insistence on equal footing in meaning-making, refusing the obfuscation of hierarchy.

### Myth: Change-Blindness

Attention prioritizes social centrality, scene gist, and the majority salience map.


Re-evaluated as

### Reality: Ecological Validity

Hyper-attention to detail is a protective asset for hazard detection, prioritizing the invariant relations that hold the physical world together.

# Clinical Recognition: The Diagnostic Lens

## The Iceberg of Assessment



## The Emotional Context Trap

Traditional emotion recognition training fails because it isolates faces. Autistic individuals process tears absolutely (sadness), leading to clinical confusion when they misinterpret someone crying from joy (winning the lottery).

## The ABA Pitfall

Techniques enforcing “appropriate” contextual responses often merely punish autistic clarity until the individual performs the expected ambiguity, rather than teaching genuine contextual navigation (Heflin & Alberto, 2001).



# Practical Strategies: A Bifurcated Action Plan

## Environmental Adaptations (For Allies)

### Clarify the Context

**(Univers)**

Start social skills discussions from the context (where/when), not the skill (what/how). Clarify shifting rules explicitly.

### 2. Externalize the Unspoken

**(Univers)**

Make invisible social rules visible. Do not rely on "reading the room" or implied hierarchical gestures.

### 3. Model Flexible Thinking

**(Univers)**

Narrate real-time pivots out loud (e.g., "It is raining, so the park rule changes to an indoor rule").

## Self-Advocacy Tools (For Autistic Individuals)

### 1 Design Your Environment

**(Univers)**

Leverage "weak central coherence" as a design asset (Dong & Heylighen, 2018). Actively titrate sensory load to preserve cognitive bandwidth for processing.

### 2 Scripting by Context

**(Univers)**


Develop discrete internal scripts tied to specific physical environments rather than attempting to apply generic social rules globally.

### 3 Advocate for Clarity

**(Univers)**

Assert Context Sovereignty—the fundamental right to demand direct communication without navigating neurotypical double-speak.



# Connections: The Networked Brain

## 2. Sensory Gating & Allostatic Overload

Because the autistic brain assigns high precision to prediction errors (HIPPEA), it cannot use context to filter out irrelevant sensory noise, rapidly accelerating cognitive exhaustion.



## 1. Double Empathy Problem

Mutual misattunement is the rule. When an absolute economy of meaning interacts with a relative economy, both parties experience context blindness toward the other's social rules.

## 3. Monotropism

The intense, laser-like detail-sight requires tremendous cognitive resources, pulling processing power away from peripheral, ambient social context.
